The financial upgradation and consequent pay fixation will be subject to the terms and conditions stipulated in the DOP&'s O.M. No.35034/3/2008-Estt.(D) dated 19th May 2009 and further clarifications issued thereon in the matter.

The financial upgradation under ACP/MACP Scheme has been considered on the basis of references and recommendations from the respective Institutes. Therefore, it is assumed that the provision of consequential effect for grant of 02nd/ 03rd financial upgradation under ACP/ MACP Scheme in such cases, if any, where financial upgradation was referred/ postponed, in the past either on account of ACP or MACP or on account of any other reasons, adequate caution has been adhered to while sending the proposals to this office.

In the event of any overpayment as a result of financial upgradation under ACP/ MACP Scheme, if pointed out by the Audit or as a result of the Government instructions/ orders, the same shall be recoverable from the officer/official concerned.
