2. Tender Fee of Rs 500/- and Bid Security of Rs 50,000/- must be in the form of Demand Draft in favour of Director, Rain Forest Research Institute, Jorhat payable at Jorhat.
3. Hardcopies of Bid Security & Tender Fee OR its exemption certificate must reach the Office of the Director, Rain Forest Research Institute, Sotai, Near Science College (JIST), Jorhat -785010, Assam on or before the last date/ time of online submission.
4. One Tenderer/Bidder will submit only one tender document. **Conditions of Contract**

1. The tender should be uploaded online in Two parts, viz, Technical Bid and Price Bid.
2. The offers submitted by Hard Copy/Fax/Email shall not be considered. No correspondence will be entertained in this matter.
3. All pages of the bid being submitted / uploaded must be signed and sequentially numbered by the bidder irrespective of nature of content of the documents before uploading.
4. Pre bid Conference: Not Applicable
5. Technical Bid: Documents are to be furnished/ uploaded by the Tenderer/ Bidder as per the Tender Document following the sequence of the checklist.
6. Price Bid: Hard Copies of the Technical Bid and Price Bid/ Financial Bid should not be submitted physically to the Institute. The Price Bid/ Financial Bid must be uploaded in the Schedule of price bid of provided in the Tender Document.
7. Price/ Financial bids of Tenderers/ Bidders who qualify the technical bid evaluation will be opened.

**8. Clarification of Bids:**

a. To assist in the examination, evaluation, comparison of the bids, and qualification of the Bidders, the Purchaser, at its discretion, may ask any Bidder for a clarification of its Bid. The Purchaser's request for clarification and the response shall be in writing by post/email/fax etc. Any clarification submitted by a Bidder in respect to its Bid and that is not in response to a request by the Purchaser shall not be considered. No change, including any voluntary increase or decrease, in the prices or substance of the Bid shall be sought, offered, or permitted, except to confirm the correction of arithmetic typing errors noticed by the Purchaser in the Evaluation of the bids. If a Bidder does not provide clarifications of its bid by the date and time set in the Purchaser's request for clarification, its bid may be rejected.

b. The bids will be scrutinized to determine whether they are complete and meet the essential and important requirements, conditions, etc. as prescribed in the Bid Document. The bids are liable to be treated as non-responsive and will be rejected if bidder does not upload qualifying and technical documents as required in the Bid Document.

c. If during the preliminary examination, the purchaser finds any minor infirmity and/or irregularity and/or non-conformity in a bid, the purchaser may waive the same provided it does not constitute any material deviation and financial impact and, also, does not prejudice or affect the ranking order of the bidders. Wherever necessary, the purchaser will convey its observation on such 'minor' issues to the bidder asking the bidder to respond by a specified date. If the bidder does not reply by the specified date or gives evasive reply without clarifying the point at issue in clear terms, that bid may be ignored.

9. Tender Fee of Rs 500/- and Bid Security of Rs 50,000/- must be in the form of Demand Draft in favour of Director, Rain Forest Research Institute, Jorhat payable at Jorhat.

10. Hardcopies of Bid Security & Tender Fee OR its exemption certificate must reach the Office of the Director, Rain Forest Research Institute, Sotai, Near Science College (JIST), Jorhat -785010, Assam on or before the last date/ time of online submission.

11. The successful Tenderer/ Bidder will have to deposit a Performance Security of Rs 1,00,000/- (one lakh) only in form of demand draft in favour of Director, Rain Forest Research Institute, Jorhat payable at Jorhat within 15 days of award of contract. The Performance Security shall be valid for the period of

Contract and two months. It shall be released only after successful completion of the work, not later than 3 months from the date of completion of the work.

12. The Bid Security may be forfeited if:

- a. If a bidder withdraws his bid during the period of bid validity.
- b. In case of successful bidder, if the bidder fails to:
  - i. Accept the Work Order.
  - ii. Deposit the Performance Security.

13. The performance security may be forfeited in full or partially if any deviation from the terms and conditions is found during the period of contract.

14. The Tenderers shall be presumed to have carefully examined the drawings, conditions and specifications of the work and have fully acquainted themselves with all details of the site prior to tendering for the work.

15. The Successful Tenderer, referred hereafter as Contractor will work strictly according to the specifications and drawings provided. Work done with deviation from the provided specifications will not be accepted under any circumstance and it will be the responsibility of the Contractor to correct the deviations. Any bills charged for rectification of deviation (s) will not be entertained by the Institute.

16. After completion of the work the Contractor will inform the Institute in writing. The Institute will arrange for inspection and verification of the work done. Thereafter, if satisfied with the work done the handing and taking over documents will be signed.

17. In case the workers/ any worker deployed by the Contractor commit/commits any act of offence which is against the good Interest of the Institute, the Contractor will be liable and responsible to take action against the person(s).

18. In case the workers/any worker deployed by the Contractor meet with any unfortunate accident/ loss, RFRI will not be responsible and answerable to it.

19. RFRI will not be responsible in any case where the Contractor fails to comply with any Laws and if RFRI is put to any obligation, monetary or otherwise, the RFRI will be entitled to get itself reimbursed out of the bill or Performance Security of the Contractor.

20. Director, RFRI reserves the absolute right to cancel any or all the tender at any time during the bidding.

21. Director, RFRI reserves the absolute right to terminate/ stop the contract at any time during the period of the contract if any deviation from the laid terms and conditions is found.

22. The Contractor if in any manner defaults in the performance or in making good of any losses, damage or expenses or any part thereof, then it shall be lawful for the Institute to recover the loss from running monthly bills towards the liquidation of liability of the service provider in respect of such default.

23. FORCE MAJEURE. Neither party shall be responsible for delays or failures in performance resulting from acts beyond the control of the party. Such acts shall include but not limited to acts of God, strikes, lockouts, riots, acts of war, epidemics, Government regulation superimposed after the implementation, communication line failure, earthquakes etc.

24. If any dispute or disagreement arises between the bidder and the Institute under any circumstance or in connection with the term & conditions, they shall make every effort to resolve the matter amicably by direct negotiation.

25. All disputes which may arise between the service provider and Institute will be referred to the arbitrator. Arbitrator will be appointed by the Director General, ICFRE. The applicable Arbitration procedure will be as per Arbitration and Conciliation Act, 1996.

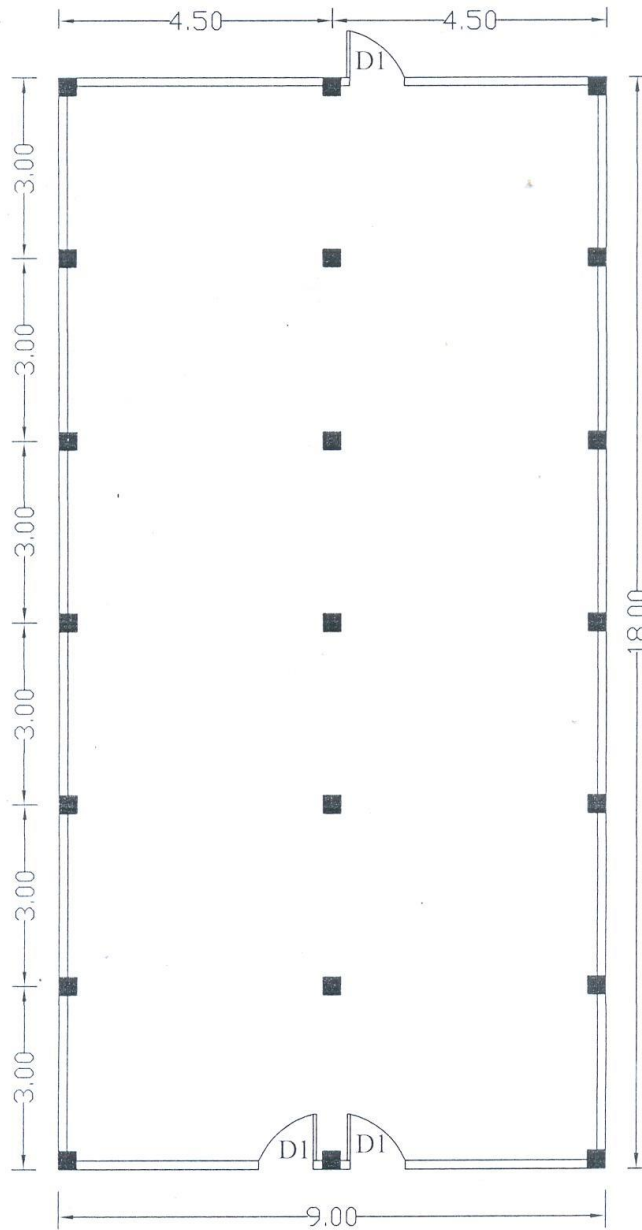

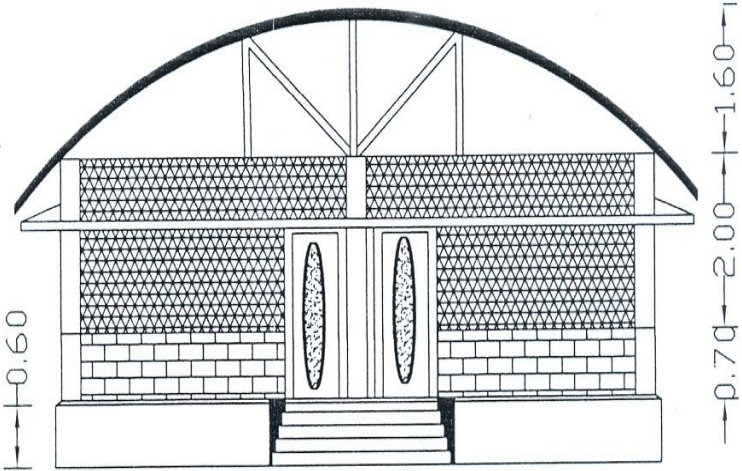
PROPOSED CONSTRUCTION OF THE A.T. ORCHID HOUSE .

**Policy of Rain Forest Research Institute, Jorhat against the Corrupt and Fraudulent Practices**

RFRI strictly adheres to its policy against corruption and requires that bidders and their agents, subagents, sub-contractors, suppliers, etc. shall not indulge in any kind of corrupt practices, fraudulent practices, collusive practices, coercive practices, obstructive practices or other kinds of corruption declared as crime under Indian law.

A) If bidder or their agents, subagents, sub-contractors, suppliers etc. are found, directly or indirectly, involved in such practices, bid or agreement and execution thereof at any stage may be rejected or cancelled as the case may be and besides it, RFRI may initiate legal actions including civil and criminal proceeding. For the purpose of this provision the terms are defined as follows:

(i) “Corrupt practice” is the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence improperly the actions of another party;

(ii) “Fraudulent Practices” is any action/ omission including a misrepresentation which knowingly or recklessly made to mislead another party to obtain financial or other benefit or to avoid an obligation;

(iii) “Collusive Practice” is an arrangement between two or more parties designed to achieve an improper purpose, including to influence improperly the actions of another party;

(iv) “Coercive Practice” is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the action of a party;

(v) “Obstructive Practice” is deliberately destroying, falsifying, altering, or concealing of evidence material of the investigation or making false statements to investigators in order to materially impede an investigation into allegations of a corrupt, fraudulent, coercive or collusive practice; and/or threatening, harassing.

1. For the purpose of this sub-paragraph, “another party” refers to a public official acting in relation to the procurement process or contract execution. In this context, “public official” includes RFRI staff and employees of other organizations taking or reviewing procurement decisions.

2. For the purpose of this sub-paragraph, “party” refers to a public official; the terms “benefit” and “obligation” relate to the procurement process or contract execution; and the “act or omission” is intended to influence the procurement process or contract execution.

3. For the purpose of this sub-paragraph, “party” refers to participants in the procurement process (including public officials) attempting either themselves, or through another person or entity not participating in the procurement or selection process, to simulate competition or to establish bid prices at artificial, non-competitive levels, or are privy to each other’s bid prices or other conditions.

4. For the purpose of this sub-paragraph, “party” refers to a participant in the procurement process or contract execution intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation.

B) Besides actions under clause (A) RFRI may also take action to blacklist / ban such bidder either indefinitely or for a specified period.
