1. Project Background: India's forest and tree cover comprises of 24.62% of its total geographical area and play a vital role in ecological and economic development of the country. However, forests are degraded to meet the increasing demand of fuel, fodder, timber and nontimber forest products. Competing uses of land for agricultural, infrastructure developmental projects, human settlement and industries exerts tremendous pressure on the finite land resources of the country. Rising atmospheric CO₂ concentration and climate change are additional stress on the forests and making them more vulnerable. Despite pressures on the forests for development purposes, India is pursuing to achieve its National Forest Policy's Goal and international commitments (Nationally Determined Contribution target, Land Degradation Neutrality target, Biodiversity Targets, Sustainable Development Goals and Bonn Challenge target) by 2030. NDC target for forestry sector is to create an additional carbon sink of 2.5 - 3 billion tonnes of CO₂ equivalent through additional forest and tree cover by 2030. To reduce the pressure on existing forests, to meet the increasing demand of forest produces and to achieve national targets and international commitments, some transformative actions need to be taken for forest landscape restoration. Forest and tree cover can be increased significantly by taking up plantation and afforestation outside the forests, and restoration of degraded forests and scrub forests. Agroforestry, farm forestry and urban forestry can help in increasing the forest and tree cover of the country.

German Federal Ministry for the Environment, Nature Conservation, Nuclear Safety and Consumer Protection (BMUV) has commissioned a project titled Restore, Conserve and Protect Forest and Tree Cover for NDC Implementation in India (RECAP4NDC) under International Climate Initiative. The project will be implemented as part of the Indo-German Partnership for Green and Sustainable Development by a six-member consortium (GIZ - coordination and lead, International Union for the Conservation of Nature - India, Forest Survey of India, The Energy and Resources Institute, Indian Council for Forestry Research and Education and the International Centre for Integrated Mountain Development). This project aims to enable actors to effectively plan, finance, implement and monitor forest landscape restoration and trees outside forests measures. Thereby, it aims to contribute to the achievement of India's NDC forestry target, enhance biodiversity conservation and sustainably improve rural livelihoods through increased forest and tree cover.

Indian Council for Forestry Research and Education (ICFRE) is one of the consortium partners and will have main responsibilities in output V (capacities, knowledge and communication) and will also contribute to output I (FLR model implementation) and output IV (policy and

planning) of the project. Output V aims to transfer knowledge and capacitate national and international stakeholder groups. Capacity development includes trainings, induction courses/curricula development on FLR for public staff across different sectors and levels. Efforts will be made to work extensively with premier forestry institutions such as Indira Gandhi National Forest Academy. The output includes community empowerment and concrete community action for on-ground activities, which will be pursued in cooperation with Gram Panchayats, Van Panchayats, Forest Development Committees, Biodiversity Management Committee, Resident Welfare Associations, and other CSOs/NGOs. Another aspect of output V refers to international experience exchange in South-South formats and within the Indo-German cooperation by organising an Indo-German platform on FLR, participation in seminars, conferences, exposure visits with scientific and policy institutions in Germany, Europe and India.

2. Scope of Services and Tasks

Support the implementation of the various activities of the project on 'Development of capacities, knowledge and communication mechanisms for FLR', and support in execution of output I (FLR model implementation) and output IV (policy and planning) of RECAP4NDC Project. Coordination functions dealing with a wide range of stakeholders of the project. Consultant will have to perform the following services and tasks:

a. Trainings on FLR

- Support in conducting need assessment for trainings across different sectors and levels of staff, and community members
- Support in conducting need sensitization and awareness training on specific aspects of FLR for local communities in model sites including public and community actors.
- Support in developing training modules including e-learning modules and certification courses for state technical staff and training manuals

b. Community empowerment for FLR

- Supports in identification of suitable cooperation partners for community empowerment
- Support in conducting specific capacity development packages for communities including sensitization, interactive trainings, campaigning, community action, actions for schools/ students.

c. Knowledge exchange/ management for FLR

• Support in documentation of lessons learnt and best practices from model sites conducted in output- I through appropriate formats including E-tools.

d. Other duties/additional tasks

 Perform other duties and tasks assigned by the authorities for implementation of the project activities

Data and documents/ reports /papers etc. generated by the consultant under the project will be the sole property of ICFRE. Consultant shall ensure to hand over print and electronic copies of data and documents/ reports /papers to the Project Management before completion or termination of the contract.

Performance of the consultant will be measured against assigned work plan and it will be updated on annual basis. Consultant will submit yearly progress reports stating her/his

accomplishments against the agreed work plan and also submit any other reports as required by the project management.

3. Essential Qualifications and Experiences

- The candidate must hold a Master Degree in Forestry/ Forest Management/ Agroforestry/ Environmental Science/ Environmental Management/ Natural Resource Management/ Botany/ Soil and Water Conservation/ Land Management/ Ecology/ Climate Change/ Soil Science or other related subjects.

4. Desirable Competency

- Holding Ph. D. degree in the relevant fields will be an added advantage.
- Working experience in the project implementation States (Delhi & NCR, Gujarat, Maharashtra and Uttarakhand) will be an added advantage.
- Demonstrated experience of working at landscape level, in organising capacity building programmes and knowledge management in the field of forestry will be an added advantage.
- Excellent inter-personal skills in working with various stakeholders, project partners will be an added advantage.
- Ability to work effectively in a team, interacts persuasively with a range of stakeholders, and travel extensively in the project state.
- Fluent written and oral knowledge of English and Hindi is a must and fluency in local language of the state(s) will be an added advantage.

5. Maximum Age Limit: 65 years as on last date of submission of the application

6. Support/ Inputs to be provided to the Consultant

- Furnished office space
- Computer and internet facility
- Relevant documents required for implementing the project activities
- 8 leaves in a single year of consultancy
- Traveling expenditure as per Government of India/ ICFRE norms

7. Location

Consultant will be based at ICFRE, Dehradun. However, contracts involve extensive long duration touring in the project areas for execution of project activities. State(s) will be assigned to each consultant by the Project Management separately for providing necessary supports and inputs in implementation of the project activities in the states of Delhi & NCR, Gujarat, Maharashtra and Uttarakhand.

8. Duration of the Contract

Duration of the contract for this assignment will be for the period of 5 years or completion of the project or whichever is earlier. However, performance of the consultant will be reviewed on yearly basis. In case of unsatisfactory performance during the period, contract can be terminated by giving two months' prior notice to the consultant. In case consultant wants to leave the contract, two months prior notice need to be submitted by the consultant.

9. Category of Consultant and Remuneration/ Fee

Category of the Consultant: Consultant "Senior Consultant". The consolidated monthly remuneration of the consultant will be Rs. 1,25,000/- per month and TDS will be deducted as per the Income Tax Norms. Consultant shall be entitled to 8% annual increase in their remuneration subject to the satisfactory performance of the consultant. Travel expenses for the travel undertaken by the consultant for project works will be reimbursed as per the norms of the Government of India/ICFRE. No other allowances would be reimbursed or paid to the consultant.
