**ORDER**


In partial modification of this office Order No.31-17/99-ICFRE dated 02.04.2012, the Director General, Indian Council of Forestry Research & Education is pleased to order as follows:-

1. The Forest & Climate Change and Biodiversity Conservation Division shall be merged and renamed as "Biodiversity & Climate Change (BCC) Division"
2. The BCC Division will function under the Directorate of Research and in future any project(s) which are related to Forest & Climate Change/Biodiversity will be handled by the BCC Division only under the Directorate of Research.

The policy of ICFRE is that one Assistant Director General should not simultaneously report to two Deputy Director Generals in the Council. In pursuance of the said policy, the Director General, ICFRE is pleased to order that:

1. Dr. T.P. Singh, ADG (Forest & Climate Change) is posted as ADG (Biodiversity & Climate Change) under the Directorate of Research, ICFRE. However, Dr. T.P. Singh shall continue to report to DDG (Extension) regarding work related to SLEM Project till 30<sup>th</sup> June 2014, when the project is coming to its end.
2. Shri Vivek Khandekar, Director (Biodiversity Conservation) is transferred from the Directorate of Extension to Directorate of Administration and posted as ADG (Admin), ICFRE. He will take over the charge of the post of ADG (Admin) from Shri S.D. Sharma w.e.f. 04.06.2014. Shri Vivek Khandekar will also look after the charge of the post of Head, Internal Audit Cell, ICFRE until further orders.
3. Shri Pankaj Aggrawal, ADG (EM) will hold the additional charge of the post of ADG (Media and Extension), ICFRE and take over the additional charge from Shri Vivek Khandekar, ADG (Media & Extension) w.e.f. 04.06.2014 until further orders.

Compliance to above orders may be sent to this office.


