To bidders are required are required to submit their bids on the e-tender portal using valid Digital Signature Certificate. Registration: - Intending bidders are requested to register themselves with <http://moefcc.euniwizarde.com> for obtaining user-id, by paying a registration fee, online tender processing fee etc. as required for registration.

The Prices should be quoted in the following manner:

1. The price quoted for the item of works would include the cost of materials required as per the specification specified in the said item of work as well as labour charges etc. including all excise duty and sales and other taxes already paid or payable for the said work.
2. The Director, Tropical Forest Research Institute, Jabalpur reserves the right to reject any or all the tenders without assigning any reasons whatsoever.
3. Tenders/Bidders who has downloaded the tender form the <http://moefcc.euniwizarde.com> and <http://tfri.icfre.gov.in/>. shall not tamper/modify the tender form including downloaded price bid template in any manner. (2) Two bid systems TECHNICAL & FINANCIAL PROPOSAL.

(a) TECHNICAL EVALUATION

Evaluation of Qualifying Documents: Tenders shall be scrutinized and evaluated by the Technical Committee or a Committee constituted by competent authority with reference to parameters prescribed in the Bid Document. First of all, the qualifying documents of the bid will be checked and in absence of any qualifying documents the bid will be rejected.

(b) FINANCIAL PROPOSAL

The financial proposal must be submitted in the format as per the price schedule . Full details of business terms and conditions, e.g. packing and forwarding, delivery period, GST/Sales Tax/Trade Tax (whether provincial or Central), other Taxes/Charges, if any, the validity period of quotation, discount, free delivery, packing or any other information relevant to the items may please be indicated clearly. Prices must be quoted F.O.R. at T.F.R.I. Jabalpur in Indian Rupees.(INR) only. The bid shall be inclusive of all duties and levies except for excise duty/customs and sales tax at the prevailing concessional rates. **Offer rate shall be valid for three months form date of opening of financial bid.**

(c) SUBMISSION OF PROPOSAL

Financial and Technical Proposals containing the qualifying documents and EMD self attested scanned copy should attached.

(d) PROPOSAL EVALUATION

Two bid systems procedure will be adopted in evaluating the proposals

- (i) Checking of qualifying documents. This will be the documents, which shall be checked, and disqualification amongst these documents will lead to rejection of the proposal *in toto*,
- (ii) A technical evaluation of the qualified firm on the basis of the qualifying documents will be carried out prior to opening of their financial proposal,
- (iii) After financial evaluation. Firms will be ranked using a combined technical / financial score as indicated below.

(f) Technical Calculation

The evaluation committee appointed by the client will carry out its evaluation applying the evaluation criteria and point system as specified below. Each responsive proposal will be attributed a technical score (St.).

The technical proposal should score at least 70 points out of 100 to be considered for financial evaluation.

(3)Financial Proposal

The evaluation committee will determine if the financial proposals are complete and without computational errors. The lowest financial proposals (F_m) will be given a financial score (S_f) of 100 points. The financial scores of other proposals will be computed as follows $S_f = 100 \times F_m / F$ (Where F is amount of financial proposal).

Proposal will finally be ranked according to their combined technical (S_t) and financial (S_f) scores using the formula $S = S_t \times T\% + S_f \times F\%$.


The weight ($T\%$) given to the Technical Proposal is 60%

The weight ($F\%$) given to the Financial Proposal is 40%

Chapter-3

TERMS & CONDITIONS

1. There will be no manual or by email submission of documents.
2. E-tender must be electronically submitted through online within prescribed data and time as mentioned in the e-procurement portal. Hard copy of the E-tender documents will not be accepted.
3. EMD & tender fee are to be submitted through DD, in favour of the Director, Tropical Forest Research Institute, payable at Jabalpur and the scanned copy/soft copy of the same shall be uploaded along with the Technical Bid. Offers/Bids without physical E-tender fees and the EMD would not be considered and rejected on opening date.
