3	Parth Yuva Mandal	▪ Out of three work orders, one work order is of year 2019.

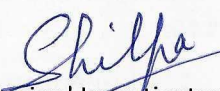
5. On evaluation of the EOI proposals, following six (06) NGOs met the prescribed qualification/ eligibility criteria as per the REOI document:
